

## **Official Contest Rules –**

# **2017 Yard Sign Photo Contest**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** This Contest is open only to those who follow the district Facebook page of the district they are registered in and are thirteen year of age as of the date of entry. The Contest is only open to US legal residents that are registered with the Boy Scouts of America, and is void where prohibited by law. Employees of Boy Scouts of America, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
2. **Agreement to Rules:** By participating, the Contestant (“You” or “Your”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that you meet the eligibility requirements. In addition, you agree to accept the decisions of Boy Scouts of America as final and binding as it relates to the content of this Contest.
3. **Contest Period:** Entries will be accepted on Facebook starting on August 19 at 12:00 a.m. CT and ending on September 29 at 11:59 p.m. CT.
4. **How to Enter:** The Contest must be entered by following your district page on Facebook. Post a photo showing your yard sign. The yard sign can be anywhere visible in the community such as your home, school, or business. Must abide by local laws if the yard sign is not on your private property. Use the hashtag “#buildanadventure. Post picture on your district Facebook page. You will automatically be entered and your Facebook photo will be displayed in the guest post area. Entries that do not adhere to the rules or specifications may be disqualified at the sole discretion of Boy Scouts of America.
5. **Prizes:** Six (6) Winners per participating district will win one prize of a \$20 Visa or MasterCard gift card. Visa and MasterCard in no way endorses, sponsors, administers, or associates with this contest. The specifics of the prizes shall be solely determined by Boy Scouts of America. One (1) Cub Scout Pack per participating district with the most number of posts representing their pack throughout the duration of the contest will win an ice cream

party. No cash or other prize substitution shall be permitted except at Boy Scouts of America discretion. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. Regardless of winning acceptance of the rules provides permission for Boy Scouts of America to use name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

6. Winner Selection and Notification: All eligible entries received will be judged by a Bay Lakes Council professional. Winners will be notified via Facebook by the Friday of each week that the contest is in existence. Dates: August 25, September 1, September 8, September 15, September 22, and September 29. Boy Scouts of America shall have no liability for Winner's failure to receive notices due to spam or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize by the specified Friday dates above at 11:59 p.m. CT the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this Contest is conditioned upon compliance with any and all federal, state, and local laws and regulations. If the content of your entry is claimed to constitute infringement of any proprietary or intellectual proprietary rights of any third party, you shall, at your sole expense, defend or settle against such claims. proceeding, claims, liability, loss, damage, costs or expense, which Boy Scouts of America may incur, suffer, or be required to pay arising out of such infringement or suspected infringement of any third party's right.

Terms & Conditions: Boy Scouts of America reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Contest should virus, bug, non-authorized human intervention, fraud, or other cause beyond Boy Scouts of America's control corrupt or affect the administration, security, fairness, or proper conduct of the Contest. In such case, Boy Scouts of America may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Boy Scouts of America. Boy Scouts of America reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or website or violates these Terms & Conditions.
